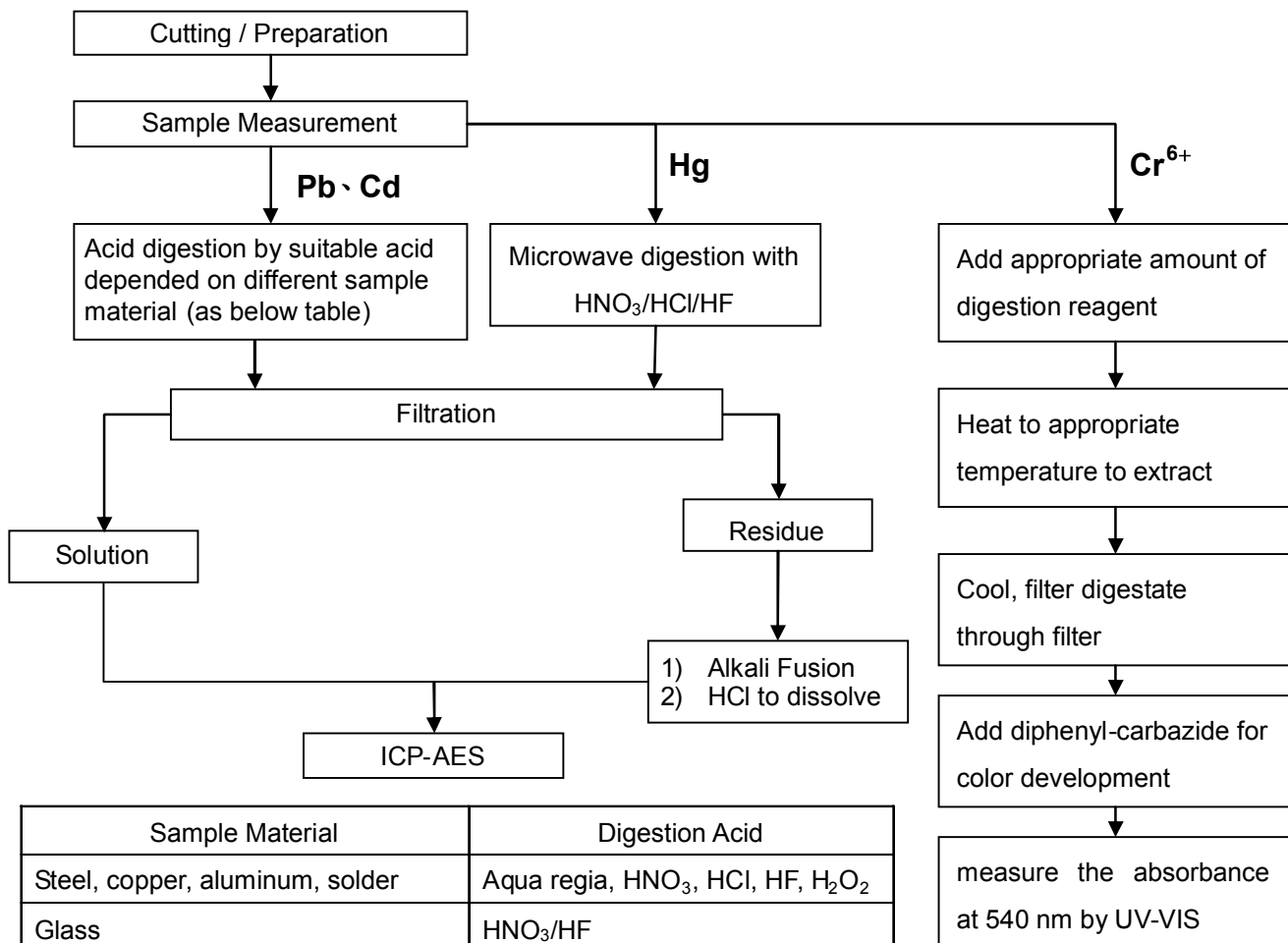

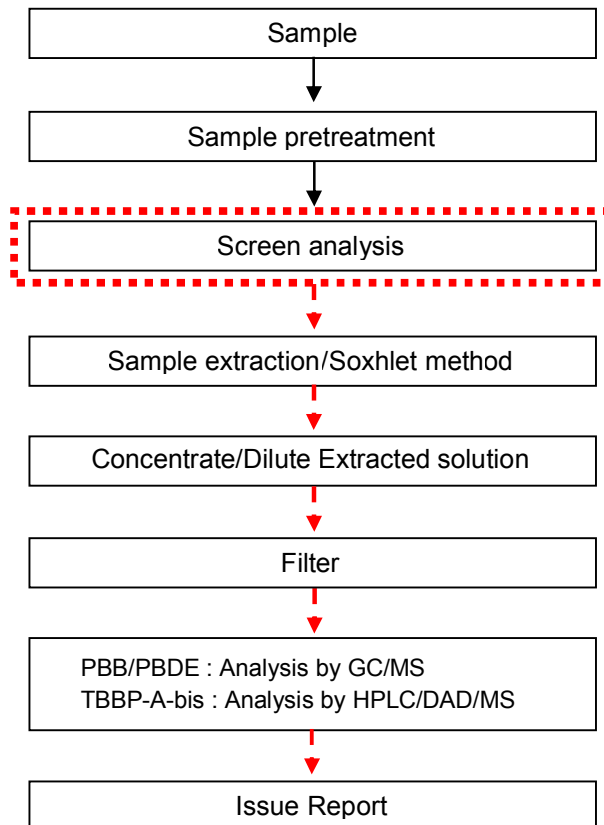


Analytical flow chart

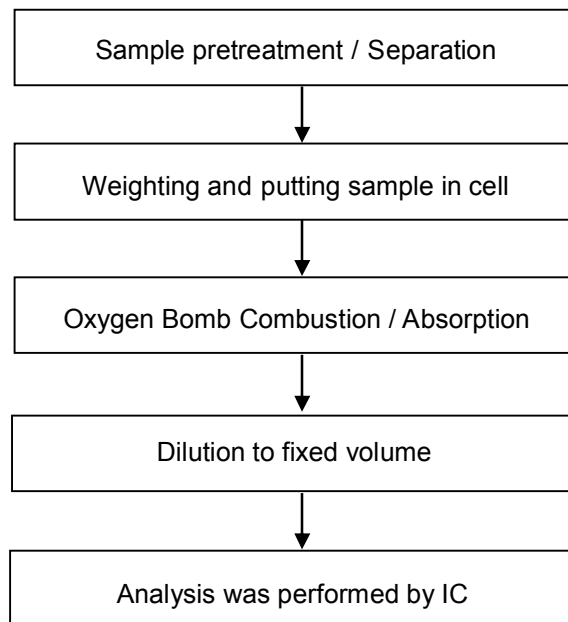

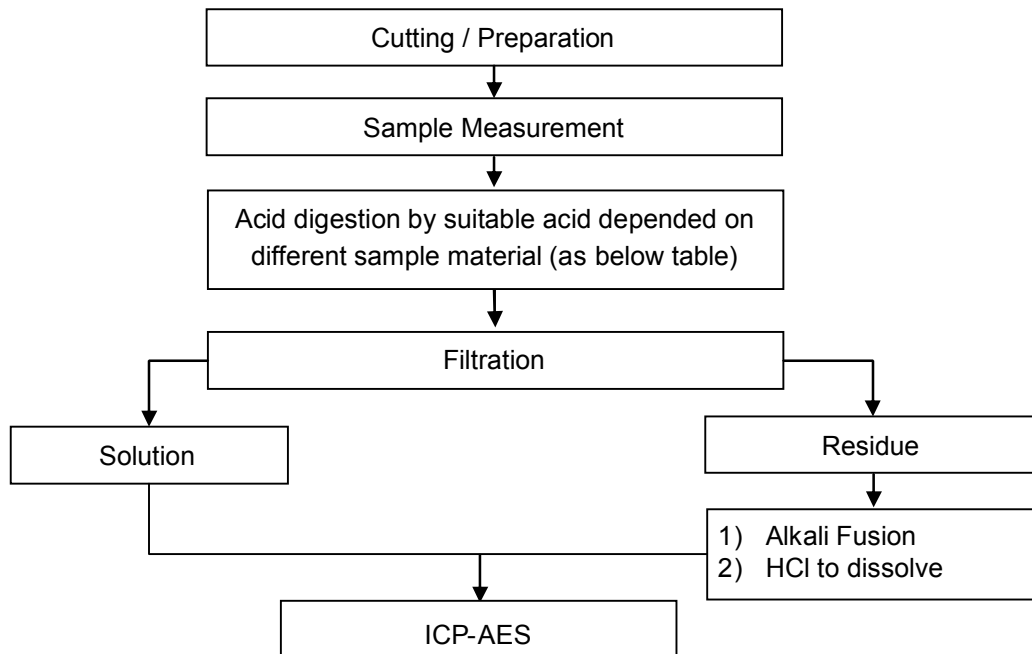

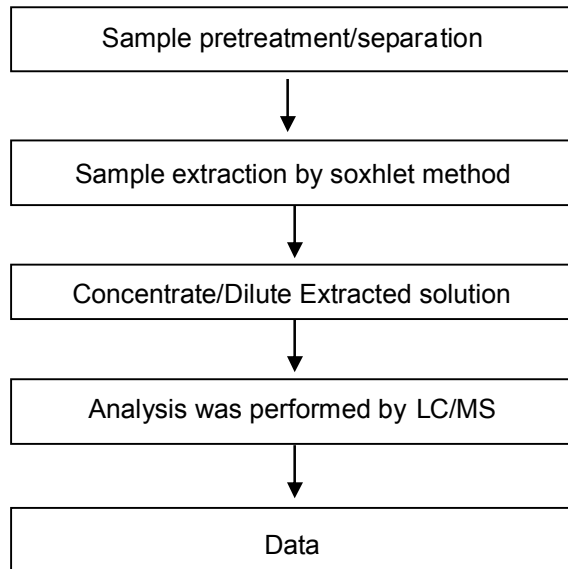

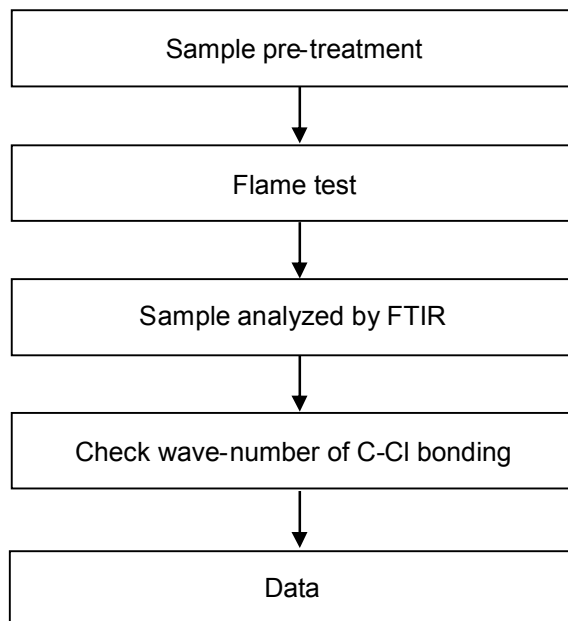

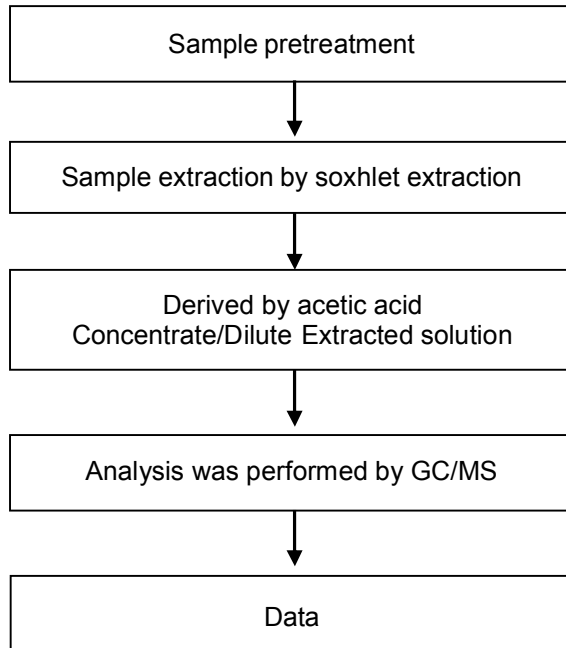
